	And, such courses will not count toward the 24 hours
	of required business courses. Furthermore, a student
	who has credit in both undergraduate and graduate
	level for the introductory "management" accounting
	course will only receive credit for one of the courses
	in satisfying the 150 hour requirement to become
	licensed. In addition, such courses do not substitute

	for the required financial reporting related "Cost" or "Managerial Cost" accounting course which is required for accounting majors and which emphasizes cost accounting and financial reporting of inventories for manufacturers, production activities, processors and related topics.
