

Candidates who first sat before February 1, 1995, must have met the requirements in effect at that time. NOTE: Mississippi law (Code Section 73-33-5)) has been revised effective July 1, 2016, to allow examination candidates to sit for the CPA exam with a baccalaureate degree of at least 120 collegiate-level semester hours. Minimum 48 semester hours upper division or graduate level accounting and business related courses. Accounting courses must be a minimum 24 of the 48 hours and include at minimum, three semester hours in: Financial Accounting—Auditing—Taxation—Management/Cost Accounting—Government/Not-for-Profit Accounting—Government/Not-for-Profit Accounting

Subject: CPA Exam Eduction requirements

Mr. Brownie,

Your email with attached letter has been forwarded to me. My answer below will be predicated upon your institution being accredited by at least a regional accrediting body per our Rule 2.2.1. (Mississippi Laws and Rules covering public accountancy can be found on our website – www.msbpa.ms.gov). Does your institution have such accreditation?

Also contained in Rule 2.2.1. is the requirement for at least 3 semester hours of upper division "management/cost accounting". Your statement that our statute required "Management Accounting" is incorrect and incomplete for the following reasons:

- The requirement is in our Rules, not statute (not in MS Code Section 73-33-5),
- The requirement is for either Management or Cost Accounting,
- The requirement is for an "upper division or graduate level class".

If the ACCT 320 class that you reference is an upper division (college junior or senior level class – not freshman or sophomore level), then it *appears* that it would satisfy that one course requirement in our Rules. If you have a student contemplating application to sit for the exam as a Mississippi resident, I would strongly encourage a thorough reading of the entirety of our Rule 2.2. An official consideration of any coursework towards the CPA exam educational requirement will only be done at the time of receipt of an application to sit for the CPA Exam. Such application can be done online via our website referenced above.
